
MONTGOMERY COUNTY MUNICIPAL UTILITY DISTRICT NO. 113

The Board of Directors of Montgomery County Municipal Utility District No. 113 will hold a regular meeting on Monday, June 20, 2016, at 12:00 p.m., at **4001 Sherwood Lane, Houston, Texas**, to discuss and, if appropriate, act upon the following items:

1. Minutes of prior meeting(s).
2. Comments from the public.
3. Interlocal Cooperation Agreement Between Montgomery County, Texas and the District for supplemental patrol services.
4. Tax assessment and collections matters, including payment of tax bills.
5. Authorize delinquent tax attorney to proceed with collection of delinquent taxes.
6. Financial and bookkeeping matters, including payment of the bills and review of investments.
7. Report regarding development in the District, including:
 - a. Woodforest; and
 - b. Bonterra at Woodforest.
8. Engineering matters, including:
 - a. authorization to design facilities and approval of contracts for design of construction projects in the District.

 - c. review of bids and award of contracts and authorization to execute letter financing agreements for construction projects in the District, including:
 - i. water, sewer, and drainage facilities to serve Woodforest, Section 64;
 - ii. water, sewer, and drainage facilities to serve Woodforest, Section 70;
 - iii. water, sewer, and drainage facilities to serve Woodforest, Section 72;
 - iv. curb returns at Overland Trace Drive and Woodforest Parkway North;
 - v. paving and appurtenances for Bonterra at Woodforest, Section 4 – Public and Private;
 - vi. construction of permanent access driveway to serve wastewater treatment plant; and
 - vii. Woodforest Ditch 4P.

- d. approval of pay estimates, change orders, and final acceptance as appropriate, for construction projects in the District, including:
 - i. water, sewer, and drainage facilities to serve Pine Island at Woodforest Section 1 (formerly, Woodforest, Section 48);
 - ii. water, sewer, and drainage facilities to serve Woodforest, Section 62;
 - iii. water, sewer, and drainage facilities to serve Woodforest, Section 63;
 - iv. water, sewer, and drainage facilities to serve Woodforest Central Pine Street;
 - v. water, sewer, and drainage for Central Pine Street (From Woodforest Boulevard to Woodforest, Section 65) (formerly, collector streets to serve Woodforest, Section 63 and Central Pine Street and Cardinal Ridge Boulevard);
 - vi. water, sewer, and drainage facilities to serve Woodforest Parkway South Extension (From Woodforest, Section 53 to Fish Creek Thoroughfare);
 - vii. water, sewer, and drainage facilities to serve Bonterra at Woodforest, Section 3;
 - viii. water, sewer, and drainage facilities to serve Woodforest, Section 65;
 - i. water, sewer, and drainage facilities to serve Bonterra at Woodforest, Section 4;
 - ix. paving and appurtenances for Woodforest Parkway North (from Overland Trace Drive to Elk Trace Parkway), including Woodforest Parkway reforestation (2013 Road Bonds);
 - x. paving and appurtenances for Woodforest Parkway South Extension (from Woodforest Section 45 to Woodforest Section 46) (2014 Road Bonds);
 - xi. paving and appurtenances for Woodforest Parkway South Extension, from Section 46 through Section 53 (2014 Road Bonds);
 - xii. paving and appurtenances for Fishcreek Thoroughfare Widening and Improvements (formally Fishcreek Thoroughfare median improvements);
 - xiii. Woodforest detention pond (ultimate);
 - xiv. major thoroughfare landscape improvements; and
 - xv. turf establishment to serve Montgomery County Municipal Utility District No. 113 Detention Pond.
 - e. permits, deeds, easements, consents to encroachment, and utility commitment letters, renewal of wastewater discharge permit;
 - f. update on GIS system; and
 - g. proposal for drainage improvements at Woodforest Parkway South.
9. Issuance of Bond Anticipation Note, including:
 - a. accept and execute Purchaser's Investment and Bid Letter
 - b. adopt Resolution Authorizing the Issuance and Execution of Bond Anticipation Note, Series 2016;
 - c. authorize the Board of Directors to sign all documents relating to the Bond Anticipation Note and authorize the District's consultants to take all necessary action to deliver Bond Anticipation Note to the purchaser; and
 - d. approve Developer Reimbursement Report and authorize disbursement of proceeds.
 10. Landscape Improvements for Bonterra at Woodforest, including:
 - a. review of bids and award of contracts and authorization to execute letter financing agreements for construction projects in the District;
 - b. approval of pay estimates, change orders, and final acceptance as appropriate, for construction of facilities, including:
 - i. Parking lot and related utilities.
 11. Landscape architect's report, including:

- a. approve proposal from TBG for design, approve of plans and specifications, and authorization to advertise for bids for construction of facilities;
 - b. review of bids, award of contracts, and authorization to execute letter financing agreements for construction of facilities; including:
 - i. Kinderwood Park, Phase 2.
 - c. approval of pay estimates, change orders, and final acceptance as appropriate, for construction of facilities, including:
 - i. Woodforest Parkway Trails;
 - ii. Woodforest 2015 Trails.
 - d. deeds, easements and consents to encroachment.
12. Operation of District facilities, billings, backcharges, and repairs and maintenance.
 13. Permanent Wastewater Treatment Plant, including:
 - a. acquisition of additional land for plant site; and
 - b. Supplemental Agreement No. 1 with Brown & Gay Engineering, Inc.
 14. Discuss changing Board meeting regular meeting date, place, and time.
