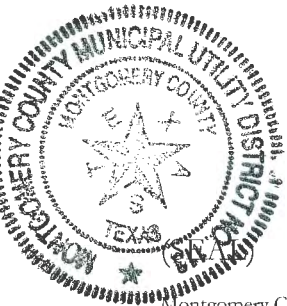


The Board of Directors of Montgomery County Municipal Utility District No. 113 will hold a regular meeting on Monday, December 19, 2016, at 12:00 p.m., at 101 Elk Trace, Montgomery, Texas, to discuss and, if appropriate, act upon the following items:

1. Minutes of prior meeting(s).
2. Comments from the public.
3. District newsletter.
4. Security matters.
5. Accept resignation of director Grigsby and discuss appointment of replacement director.
6. Tax assessment and collections matters, including payment of tax bills.
7. Series 2017 Unlimited Tax Bonds, including:
 - a. preparation of Preliminary Official Statement and Official Notice of Sale; and
 - b. Resolution Requesting Appraisal of Property and Certificate of Estimated Appraised Value.
8. Financial and bookkeeping matters, including payment of the bills and review of investments.
9. Report regarding development in the District, including:
 - a. Woodforest; and
 - b. Bonterra at Woodforest.
10. Engineering matters, including:
 - a. authorization to design facilities and approval of contracts for design of construction projects in the District, including:
 - i. paving and appurtenances for Woodforest Section 71; and
 - ii. water, sewer, and drainage facilities to serve Woodforest Section 96 (55A).
 - b. approval of plans and specifications and authorization to advertise for bids for construction projects in the District, including:
 - i. clearing of Deerbourne Ridge Drive (from Woodforest, Section 64 to Woodforest Boulevard);
 - ii. Woodforest Lift Station No. 1, Phase 1;
 - iii. water, sewer, and drainage facilities to serve Bonterra at Woodforest, Section 5;
 - iv. water, sewer, and drainage facilities to serve Bonterra at Woodforest, Section 6;
 - v. water, sewer, and drainage facilities to serve Woodforest, Section 66;
 - vi. water, sewer, and drainage facilities to serve Woodforest, Section 69;
 - vii. water, sewer, and drainage facilities to serve Woodforest, Section 71;
 - viii. water, sewer, and drainage facilities to serve Deerbourne Ridge Drive (from Woodforest, Section 64 to Woodforest, Section 69) and Taylor Crossing Drive;
 - ix. paving and appurtenances for Deerbourne Ridge Drive (from Woodforest, Section 64 to Woodforest, Section 69) and Taylor Crossing Drive;
 - x. Intersection Improvements to Fish Creek Thoroughfare; and
 - xi. sanitary sewer and drainage facilities and paving and appurtenances to serve Deerbourne Active Sports Park.

- c. review of bids and award of contracts and authorization to execute letter financing agreements for construction projects in the District, including:
 - i. water, sewer, and drainage facilities to serve Woodforest, Section 70;
 - ii. water, sewer, and drainage facilities to serve Bonterra at Woodforest, Section 4;
 - iii. paving and appurtenances for Bonterra at Woodforest, Section 4 – Public and Private; and
 - iv. curb returns at Overland Trace Drive and Woodforest Parkway North.
 - d. approval of pay estimates, change orders, and final acceptance as appropriate, for construction projects in the District, including:
 - i. water, sewer, and drainage facilities to serve Woodforest, Section 62;
 - ii. water, sewer, and drainage facilities to serve Woodforest, Section 64;
 - iii. water, sewer, and drainage facilities to serve Woodforest, Section 65;
 - iv. water, sewer, and drainage facilities to serve Woodforest, Section 72;
 - v. paving and appurtenances for Woodforest Parkway North (from Overland Trace Drive to Elk Trace Parkway), including Woodforest Parkway reforestation (2013 Road Bonds);
 - vi. paving and appurtenances for Woodforest Parkway South Extension (from Woodforest Section 45 to Woodforest Section 46) (2014 Road Bonds);
 - vii. paving and appurtenances for Woodforest Parkway South Extension, from Section 46 through Section 53 (2014 Road Bonds);
 - viii. paving and appurtenances for Fishcreek Thoroughfare Widening and Improvements (formally Fishcreek Thoroughfare median improvements);
 - ix. paving and appurtenances for Woodforest, Section 64 (collector and interior streets);
 - x. major thoroughfare landscape improvements;
 - xi. Woodforest Ditch 4P; and
 - xii. turf establishment to serve Detention Pond.
 - e. permits, deeds, easements, consents to encroachment, and utility commitment letters, renewal of wastewater discharge permit;
 - f. review of renewal and replacement analysis; and
 - g. revised proposal for sanitary sewer and drainage facilities and paving and appurtenances to serve Deerbourne Active Sports Park.
11. Landscape Improvements for Bonterra at Woodforest, including:
- a. review of bids and award of contracts and authorization to execute letter financing agreements for construction projects in the District; and
 - b. approval of pay estimates, change orders, and final acceptance as appropriate, for construction of facilities, including:
 - i. Parking lot and related utilities.
12. Parks Operations and Maintenance Agreements.
13. Landscape architect's report, including:
- a. approve proposal for design, approve of plans and specifications, and authorization to advertise for bids for construction of recreational facilities, including:
 - i. Christine Allen Nature Park; and
 - j. Fish Creek Thoroughfare Median Landscape.
 - b. review of bids, award of contracts, and authorization to execute letter financing agreements for construction of facilities;

- c. approval of pay estimates, change orders, and final acceptance as appropriate, for construction of facilities, including:
 - i. Woodforest 2015 Trails; and
 - ii. Kinderwood Park, Phase 2.
- d. deeds, easements and consents to encroachment.
- 14. Operation of District facilities, billings, backcharges, and repairs and maintenance.
- 15. Permanent Wastewater Treatment Plant, including:
 - a. review of bids and award contract for construction of plant.
- 16. Service agreement for operation and maintenance of District facilities.
